

My name is Cory Daniel and this is my testimony as to the conversation which took place around the 20th of May 2019 between myself and Forest Scott Proctor. The conversation took place on the phone and lasted approximately 15 minutes. I was put in touch with Scott through another person I interviewed in the course of this investigation. Scott did not search me out, but instead was given my phone number by the witness I'd interviewed previously. My previous interviewee had been asking questions around the area and said that she'd located the person who had ran over Isaac Kappy's body after it had hit the pavement on I-40. This person was given my phone number and this is the conversation which took place when he called me directly.

I answered and he said he'd been given my phone number by (redacted), he told me that he was the person who ran over the body. I asked him what happened.

He said that he was driving east on I-40 that morning on his way to a doctors appt when he came through Bellemont and was in the right hand lane as he approached the Transwestern over pass. He stated that there were two cars in front of him and he saw them move to the left lane. It was then he noticed what looked to be "about 18 people" standing up on top of the Transwestern overpass. He thought there might have been a protest going on, he said that was the first thing that came to his mind. He stated that they were all waving and trying to signal. It was then he looked down and saw a "piece of cardboard lying in the highway" he said that it was too late for him to swerve as he drives a jacked up F-150 truck and it would have flipped had he tried to do so. So he ran over the cardboard. As soon as he did he knew that he ran over something and began to stop, he said that at no time did he lock up his brakes. The first thing that came to his mind was that he'd run over a "box of kittens" as he'd guessed there was a protest going on. He pulled over to the right, stopped, and began walking back to the overpass. He noticed that the two other persons who'd changed lanes had also stopped and were coming back as well. When he approached the overpass it was then he noticed a leg sticking out from under the cardboard. And he thought that he was going to be in trouble.

I asked him who else was down there under the overpass and he said "Nobody".

I said "Nobody?"

And he said "Yeah, everyone was up on top of the overpass."

I said, "No one was directing traffic?"

He said, "No."

I asked what happened next.

He said: that a couple people came down off the overpass. One told him that "the man jumped" and the other told him that "the man fell."

I asked him when the emergency response showed up and he said it must have been about 5 minutes.

I said: It was 5 more minutes before the DPS showed up?

He said: "No. the DPS wasn't the first there. It was the fire department, the Camp Navajo Military Base fire department."

He said: As soon as the Fire department got there they took the cardboard off of him and immediately began CPR but it was obvious that the man was dead. He said: The man had sustained a huge wound to the side of his head and that was obviously what had killed him, and that the bone was showing through his shoulder, he guessed from where he had ran him over.

I asked him if he got a good look at the face of the man.

He said: Oh YEAH....It looked exactly like that guy on the internet everyone said it was. That actor guy. It was defiantly him.

I said, So you could make out his face then? It wasn't all messed up?

He said: No, just the side of his head, but I could still make out who it was, and it was defiantly that Isaac Kappy guy.

He said: that shortly after that the DPS showed up and began diverting traffic up over the overpass and back down to the highway. As soon as that was done they took his statement and inspected under this truck.

I asked: Why did they do that?

He said: I don't know, but they had a couple cops under there really checking stuff out pretty good.

I asked: What happened next?

He said: I took off for Flagstaff. When I came back through later that day everything was back to normal.

After this I thanked him for his time and asked him if I could call him back if I thought of anything else. He told me, "sure, No problem."

We hung up.

Since this conversation I have attempted to contact this person several times, both by phone and text messaging asking him of we could speak again. The first couple attempts I had no response. The last time I attempted, he responded in text saying, "I don't want to do it lose my number please."

I called Scott again on July 15th 2019 and he spoke to me briefly. I asked him if he would clarify his story as it wasn't matching up with the newly released Department of Public Safety and Sheriff's office reports for the incident. Scott maintained his story nearly identical to what he had told me previously. He became agitated after a few minutes told me not to contact him again and hung up on me. At this time I have not attempted to contact him again.

Also of note, the person who put me in contact with this man, has since gone missing as well. Her phone number "has been disconnected or is no longer in service" and she has quit her job with no notice and has vanished. I have attempted over a dozen times to try and contact her to no avail and her coworkers have no idea where she has gone. I have also attempted emailing her to no avail.

It is my opinion that Scott is telling the truth in this matter or at least believes he is, as his story has not wavered once. It was nearly a two-month gap between our conversations in the story he told me in the

second phone call I recorded is nearly identical to the first which I did not have the opportunity to record. In the first conversation however he did elaborate on the amount of people standing on top of the bridge waving their hands and about the cardboard he ran over what he thought was a box of kittens. I find the matter of Scott's story of the cardboard extremely relevant, extremely persistent, extremely bizarre.

I would also like to add that the story he told my first interviewee is also identical to the story he told me on both occasions. And now that person is missing or in hiding. She quit her job shortly after our interview and her coworkers have not seen or heard of her since.

I swear that everything I've written here is true to the word to the best of my knowledge. I'm willing to testify under oath to these words and my testimony of these events should this matter ever go to court.
