**PLAINTIFF'S SECOND SUPPLEMENTAL FILING IN CONNECTION WITH
PLAINTIFF'S MOTION FOR INJUNCTIVE RELIEF**

Pursuant to Florida Rule of Civil Procedure 1.610 and other applicable law, Plaintiff, Gabe Hoffman, (hereinafter "HOFFMAN"), hereby submits a second supplemental filing in connection with the previously filed Motion for Injunctive Relief against Defendant THOMAS SCHOENBERGER (hereinafter "SCHOENBERGER") based upon facts and circumstances previously presented, and additional actions supplemented herein:

1. On July 17, 2020, Plaintiff filed a Motion for Injunctive Relief ("Motion for Injunctive Relief") (Filing# 110428919).
2. As a result of SCHOENBERGER'S retaliatory actions **after** the filing of Plaintiff's Motion referenced above, Plaintiff then filed an Emergency Motion for Injunctive Relief on July 21, 2020 ("Emergency Motion") (Filing# 110562176).
3. SCHOENBERGER outrageously continued his relentless campaign of defamation, stalking, and harassment against HOFFMAN, after the filing of the Emergency Motion, necessitating Plaintiff's Supplemental Filing in Connection with Motion for Injunctive Relief of August 7 ("Supplemental Filing") (Filing # 111460586).

THE SECOND SUPPLEMENTAL FILING

4. In just four days, between August 8 – 11th, SCHOENBERGER has created eight additional videos on his YouTube channel, for the primary purpose of hurling defamation, harassment, stalking, and anti-Semitic hatred against HOFFMAN. These videos are in addition to the forty-two videos created from July 1-August 6, set forth in the previous Supplemental Filing, Emergency Motion and Motion for Injunctive Relief.

- a. Eleven similar videos created by SCHOENBERGER from July 21 – August 6, documented in Plaintiff's Supplemental Filing on August 7th (Filing # 111460586).
- b. Seven similar videos created by SCHOENBERGER from July 18 – 20, documented in Plaintiff's Emergency Motion on July 21st (Filing #110562176).
- c. Twenty-four similar videos created by SCHOENBERGER from July 1 - 14, documented in Plaintiff's Motion for Injunctive Relief on July 17th (Filing #110428919).

5. SCHOENBERGER also created numerous additional social media posts on Twitter subsequent to August 7th, a small sample of which are attached as Exhibit D. These include: i) a false, defamatory and obscene reference to HOFFMAN as “aggressively psychotic Gay Dolphin”— “Gabe is suspect number 1” (in SCHOENBERGER's imagined “Isaac Kappy murder conspiracy”); and ii) a claim that “Hoffman was the sentry dog of the “warehouse”, in a reply to a conspiracy post involving the Mossad (the secret intelligence agency of Israel and numerous public figures) which was created by SCHOENBERGER's online associate @GucciferInfinit on Twitter, aka Jonathan Wolfe, a Jib Camera operator for Infowars / Alex Jones.

**SCHOENBERGER APPEARS TO BE IN THE PROCESS
OF DESTROYING EVIDENTIARY MATERIALS.**

6. On August 7, Plaintiff filed a First Request for Production to Defendant and Notice of Service of Plaintiff's First Interrogatories, which requested all communications identifying, reflecting, or referring to Isaac Kappy, or HOFFMAN, subsequent to May 13, 2019, on all communication accounts used or accessed (directly or indirectly) by Defendant, including, but not limited to, Twitter, and other social media.

7. **Subsequent to Plaintiff filing, SCHOENBERGER appears to have intentionally de-activated or disabled his Twitter account @comeoutswing in, on or about August 10. This Twitter account @comeoutswing in has been the primary Twitter account utilized by SCHOENBERGER, for approximately the past 4 months.**

8. On August 11th, SCHOENBERGER stated on one of his less frequently used Twitter accounts, @namemysock, that "It's Thomas by the way, my other account got nuked". SCHOENBERGER, in writing "my other account was nuked", appears to be indicating that SCHOENBERGER's prior main Twitter account, @comeoutswing_in, was permanently suspended by Twitter. (Exhibit B).

9. **The August 11th profile of the Twitter account @comeoutswing in, clearly indicates that the account was not permanently suspended by Twitter, as SCHOENBERGER appears to claim.**

10. For example, a previous Twitter account used by SCHOENBERGER is @watchingwtrboil, one of many accounts operated, or accessed by SCHOENBERGER, which has been permanently suspended by Twitter, for numerous violations of Twitter's Terms of

Service. The Twitter profile for @watchingwtrboil indicates “Account suspended”, as of August 11th. (Exhibit A).

11. In contrast, the Twitter account for @comeoutswing_in, as of August 11th, indicates “This account doesn’t exist”, indicating that the account was either temporarily or permanently de-activated by SCHOENBERGER, subsequent to the filings by Plaintiff of Plaintiff’s First Request for Production to Defendant and Notice of Service of Plaintiff’s First Interrogatories, on August 7th.

12. Upon information and belief, SCHOENBERGER has utilized Twitter to engage in many Direct Messages (DMs), with individuals, and with groups of individuals simultaneously, in which SCHOENBERGER has directed and coordinated his campaign of defamation, harassment, and stalking against HOFFMAN.

**ADDITIONAL DEFAMATORY POSTINGS
AND ALESSANDRO VALERIN CASTELLON**

13. On August 10, SCHOENBERGER created a video on his YouTube channel, which he titled “Florida rumors. Is there going to be a fist fight or yelling match?” In that video:

- a. SCHOENBERGER defamed HOFFMAN, accusing HOFFMAN of imagined “shady financial dealings”, of which SCHOENBERGER offered no evidence whatsoever, and claimed HOFFMAN was hiding the entirely fabricated crimes from the FBI, SEC, and FINRA, while repeatedly referring to HOFFMAN in a defamatory and obscene manner, as “Gay dolphin”.
- b. SCHOENBERGER claimed knowledge of an individual named “Aless”, who recently traveled to Florida, or was headed to Florida, to “confront” HOFFMAN, and “go have a showdown” with HOFFMAN.
- c. **Alessandro Valerin Castellon (AVC) aka “Louder Than Love”, a National of Costa Rica, is an online co-conspirator and associate of SCHOENBERGER, who has emailed multiple specific death threats to HOFFMAN, and posted**

multiple desires to murder HOFFMAN on social media accounts. (Exhibit C).

- d. Similar to SCHOENBERGER, AVC has also engaged for the past year in a crazed campaign of defamation against HOFFMAN, in their imagined “Isaac Kappy murder conspiracy”.
- e. SCHOENBERGER repeatedly communicated with AVC, regularly and publicly promoted defamatory content by AVC, publicly praised the defamatory content created by AVC against HOFFMAN, and publicly defamed HOFFMAN for his ultimately successful efforts in reporting the hundreds of defamatory actions by AVC targeted against HOFFMAN as Terms of Service violations, resulting in the permanent suspension of accounts held by AVC on Patreon, PayPal, and Twitter.
- f. **AVC has previously made multiple specific death threats directly to HOFFMAN via email, indicating a specific plan to travel to Florida to “cut your face open”, “take a plane to Florida and choke the life out of you with my own hands”, as well as several other, similar threats.** AVC has posted desires to murder HOFFMAN, in the future, on Twitter and Facebook accounts operated by AVC, which were subsequently suspended, due to reporting by HOFFMAN. To alert the public, HOFFMAN has publicly posted evidence of these repeated death threats by AVC on the Twitter account operated by HOFFMAN. HOFFMAN has reported all of these matters to Federal and Local Law Enforcement, in extensive detail.
- g. **SCHOENBERGER created a YouTube video on February 22, two days after AVC emailed multiple death threats to HOFFMAN, titled “The State of the Disunion”, in which SCHOENBERGER discussed the prospect of AVC successfully executing his stated plan to travel to Florida and commit violent harm to HOFFMAN. During the video, SCHOENBERGER discussed the prospect of AVC causing physical harm to HOFFMAN, and SCHOENBERGER repeatedly laughed audibly.**

**“GAY DOLPHIN POSTS”/FINANCIAL CRIME CLAIMS/ZACH MCQUAID AND
ANTI-SEMITIC HATRED**

14. On August 10, SCHOENBERGER created a nine-minute video on his YouTube channel, which he titled “It’s pretty disgusting when gay dolphins pick on mothers.” SCHOENBERGER refers to HOFFMAN in a false, defamatory, and obscene fashion as “Gay dolphin”, defames HOFFMAN as a “possibly corrupt hedge fund manager”; “he’s a scam artist to me, he’s a criminal, he is an absolute criminal”. SCHOENBERGER refers to HOFFMAN as a “demon”, “this little shrimp that we’re dealing with in Florida that’s a personal monster”.

15. SCHOENBERGER defames HOFFMAN, falsely claiming that HOFFMAN is behaving in a similar fashion to mass murderer “psychopath” Ted Bundy, and notorious child rapist Jeffrey Epstein.

16. On August 10, SCHOENBERGER created a YouTube video, which he titled “Gay dolphins aren’t very good with investments. Choose wiser fish”, in which SCHOENBERGER once again refers to HOFFMAN in an obscene and defamatory fashion as “Gay Dolphin”.

17. SCHOENBERGER defames HOFFMAN, falsely claiming, without evidence, that HOFFMAN has tricked and fooled people into falsely believing that HOFFMAN owns and operates his hedge fund.

18. SCHOENBERGER claims that he has reported imagined crimes by HOFFMAN to an “old friend of mine who currently works in enforcement with the SEC, and knows the right people to dial” (SEC is the Securities and Exchange Commission, the regulatory agency of the Federal Government, which oversees HOFFMAN’s investment company). SCHOENBERGER

also claims that “there are going to be people within our financial regulation system who are going to be looking at him hard”.

19. SCHOENBERGER defames HOFFMAN, claiming the existence of imagined financial crimes at HOFFMAN’s hedge fund, saying “there’s funny business going on financially with his capital funds, and I think that’s where the concentration is for me right now”.

20. SCHOENBERGER defames HOFFMAN, entirely fabricating a claim, that HOFFMAN made a “financial arrangement” with Manuel Chavez III, of Carson City, Nevada, in SCHOENBERGER’s imagined “Isaac Kappy murder conspiracy”.

21. SCHOENBERGER refers to HOFFMAN once again, in a false, defamatory, and obscene fashion as “Gay dolphin” and “a psychopath”, and refers to CHAVEZ as “meatball” and “a psychopath”, despite the Protective Order obtained by CHAVEZ, which expressly prohibits SCHOENBERGER from publicly harassing CHAVEZ in this manner.

22. SCHOENBERGER further defames HOFFMAN, referring to the recent Notice of Filing Affidavit of Service of Subpoena Served on behalf of HOFFMAN to Ashley Reagan Early aka Reagan Early McGregor (Filing #111485671) as “abuse of process”, further defaming HOFFMAN with an entirely fabricated claim that HOFFMAN made public the license plate number of Ashley Reagan Early aka Reagan Early McGregor, when no such information is listed in the Service of Subpoena.

23. SCHOENBERGER says, “Gay dolphin just did it to a woman, where literally he exposed her true name, uh her address, her license plate”.

24. SCHOENBERGER defames HOFFMAN with anti-Semitic hatred as a “Jewish terrorist”, saying “This guy is a terrorist, there’s no other way to put it and so, when Zach McQuaid described Gay dolphin as a Jewish terrorist, I think that’s correct”.

25. Zachary McQuaid, of Toronto, Canada, created over fifty defamatory videos targeting HOFFMAN in their imagined “Isaac Kappy murder conspiracy”, with anti-Semitic hatred, repeatedly defaming HOFFMAN as a “Jewish terrorist”. SCHOENBERGER arranged for a payment to McQuaid, via PayPal, from SCHOENBERGER’s self-described “best friend”, notable Hollywood music composer Michael A. Levine, for the expressed purpose of McQuaid creating videos targeting HOFFMAN. SCHOENBERGER committed tortuous interference against HOFFMAN, when SCHOENBERGER emailed McQuaid shortly after McQuaid was served with the Claim for Libel and Slander by HOFFMAN’s attorney in Toronto, Canada. SCHOENBERGER falsely claimed in his December 2019 email to McQuaid, an individual with a self-admitted history of mental illness via social media posts, that HOFFMAN was “impersonating” an attorney, e.g. that HOFFMAN’s lawsuit was not real. McQuaid then resumed creating dozens of additional videos on YouTube targeting HOFFMAN with severe defamation and anti-Semitic hatred.

26. On August 9, SCHOENBERGER created a video on his YouTube channel, which he titled “Still a fan of Adam green. The Gay dolphin is melting down”.

27. SCHOENBERGER begins his video defaming HOFFMAN as a “lying deceitful little rat”, saying “so let me prove to you how much of a lying deceitful little rat Gabe Alan Hoffinan is, and Dennis Klein can be thrown in that category too”.

28. SCHOENBERGER then directs additional obscenities against HOFFMAN, saying “Please keep in mind that this diminutive little asshole Gabe Alan Hoffinan is a bully of both men and women and children”.

29. SCHOENBERGER praises the notorious anti-Semitic YouTube broadcaster Adam Green, “Adam Green is a researcher. He’s a good one. He’s come up with a lot of stuff”.

30. SCHOENBERGER defames HOFFMAN with anti-Semitic hatred, falsely claiming “What Gabe wants is a kind of hands off, don’t criticize Israel, don’t criticize Netanyahu.”, and “you can’t do that because they’re Jewish, and we all know anybody who is Jewish is incapable of a crime”.

31. SCHOENBERGER then refers to, and praises, his online associates in his relentless campaign of defamation against HOFFMAN, Steve Outtrim, a New Zealand millionaire, owner and operator of the popular website burners.me, on which SCHOENBERGER’s defamation against HOFFMAN in the imagined “Isaac Kappy murder conspiracy” has been published, as well as Dean Fougere aka “Titus Frost”, who operates a YouTube channel, on which similar defamation invented by SCHOENBERGER against HOFFMAN has been broadcast: “You know Gabe, here’s what it is. You’re a bully. I know what you are. You think you scare everybody, right. You scared a lot of people until I came along. And Steve came along, and Titus came along, and you know, others.”

32. SCHOENBERGER once again defames HOFFMAN for filing a Complaint for Libel and Slander against his acolyte Zachary McQuaid of Toronto, Canada, claiming “it doesn’t take a man”.

33. On August 8, less than 24 hours after of the filing of the Plaintiff’s Supplemental Filing in Connection with Motion for Injunctive Relief of August 7, SCHOENBERGER created a new video on his YouTube channel defaming HOFFMAN, which he titled “Gay dolphin and know more news”.

34. SCHOENBERGER refers to HOFFMAN as “Gay Dolphin”, and “know more news” refers to the name of the YouTube broadcast, hosted by the notorious anti-Semitic Internet figure Adam Richard Green.

35. SCHOENBERGER defames HOFFMAN with shocking, vile, and horrendous anti-Semitic hatred, falsely claiming that HOFFMAN desires genocide for anti-Zionists, analogous to the Holocaust.

36. SCHOENBERGER says that HOFFMAN “would want those who are anti-Zionists to be packed in cattle cars and sent to concentration camps, that’s the way this guy thinks”.

37. SCHOENBERGER, referring to the Supplemental Filing, claims that “I am dealing with that right now and laughing”, and indicates that he plans to send the Supplement to the aforementioned notorious anti-Semitic Internet figure Adam Green, with the expressed hope that Green will “report on it”; further defame and harass HOFFMAN with additional anti-Semitic hatred, to Green’s large anti-Semitic subscriber base on YouTube.

38. On August 9, 2020, in a nine-minute video he titled “Powerful people face very grave risk”, SCHOENBERGER began the video by discussing the assassinations of President Lincoln and Julius Caesar of ancient Rome.

39. SCHOENBERGER then discussed what he believed to be societal responsibilities of wealthy and powerful people, before referring to HOFFMAN, with respect to the Defamation case brought against him by HOFFMAN, as well as the Claim for Libel and Slander brought by HOFFMAN against SCHOENBERGER’s conspirator Zachary McQuaid of Toronto, Canada.

40. SCHOENBERGER defames HOFFMAN as “the worst type of bully... someone who uh takes their wealth, and they persecute the poor”, and “I don’t know whether it’s because he’s short of stature in certain areas of his body, or whether he’s just a malevolent type guy, this is a guy who preys on the indigent”.

41. SCHOENBERGER concluded his video, remarking, “I think where I come in guys, is to point it out, is to say okay I’ll give you a little history lesson, maybe you guys will like it, maybe not. But we got a problem here and what we do is, um we’ve got a problem where the very wealthy are preying on the very poor, and that is a problem.

42. **The title of SCHOENBERGER’s video—“Powerful people face very grave risk”, and SCHOENBERGER’s discussion of two historical assassinations of powerful people, combined with the context of SCHOENBERGER’s defamation of HOFFMAN, send a very clear message: HOFFMAN should be assassinated, as “a problem”, in SCHOENBERGER’s sick and twisted defamation of HOFFMAN as “preying on the poor”.**

HARVEY WEINSTEIN COMPARISONS AND MORE ANTI-SEMITISM

43. On August 11, SCHOENBERGER created a video on his YouTube channel, which he titled “August 11, 2020”, in which SCHOENBERGER defames HOFFMAN, referring to HOFFMAN as “a guy in Palm Beach”, and compares HOFFMAN to the notorious rapist Harvey Weinstein.

44. SCHOENBERGER says “We know that Harvey Weinstein was paying security services and propaganda machines to further defile his victims. Sounds a lot like a guy in Palm Beach.

45. SCHOENBERGER refers to his perceived success of SCHOENBERGER’s continuous campaign of defamation, harassment, and stalking against HOFFMAN as “his reputation continues to deteriorate, he’s looking more and more frantic.”

46. SCHOENBERGER concludes the video with a threat against HOFFMAN, referring to additional future defamation, claiming that HOFFMAN will not “have a restful night of sleep for the rest of his life”, once that new defamation is “revealed”. SCHOENBERGER

says, “He doesn't understand what we know, and that has not been revealed yet, but it will be revealed. And when it is, I don't think he's going to have a restful night of sleep for the rest of his life.”

47. In the video comments, SCHOENBERGER's acolyte and online associate, Zachary McQuaid of Toronto, Canada, offers encouraging comments to SCHOENBERGER, defaming HOFFMAN. McQuaid, using his YouTube account “Zack”, writes “GOOD. That guy from Palm Beach wants to have me kill myself. He wants me to do it myself”. McQuaid refers to their shared online gang of defamation against HOFFMAN, commenting, “A lot of people and services here are getting involved now”. (Exhibit C)

48. On August 11, SCHOENBERGER created a video on his YouTube channel, which he titled “Examining The Rabbit Hole with a telescope”, in which SCHOENBERGER claimed to be planting future defamation against HOFFMAN, “So today we give you a weather forecast. I think there's going to be a hurricane at sea, maybe one around Florida... I want to let you guys know that I've been um talking to certain journalists and certain bloggers, and uh protecting myself, and things are going to be coming out in the next six months”.

49. SCHOENBERGER defames HOFFMAN, referring to HOFFMAN as one of the “actors” in his imagined “Isaac Kappy murder conspiracy” which have “used the court system, threats, intimidation, and even murder to keep people silent”. SCHOENBERGER then defames HOFFMAN, through referring to HOFFMAN as similar to the notorious child rapist Jeffrey Epstein, and Hollywood rapist Harvey Weinstein.

50. SCHOENBERGER defames HOFFMAN as a “financial terrorist”, “in the hedge fund world”, claiming that such terrorists “need to be exposed to the light of day because they

hold vast power over everything we do, and everything we see, everything we're programmed to believe. So today it begins".

WHEREFORE, given the ongoing ugly nature of SCHOENBERGER'S defamatory statements and his tortious interference with HOFFMAN'S business relationships, the threat of a known terrorist group being appealed to (QAnon) to assist SCHOENBERGER and the likelihood that this terrorist group could take action against HOFFMAN to assist SCHOENBERGER in his misguided crusade against HOFFMAN, the public interest is served by entering a temporary and permanent injunction against SCHOENBERGER, restraining him from the relief requested in the Motion for Injunctive Relief, pp. 16-18.
