MOTION FOR REHEARING AND AMENDED MOTION TO VACATE ORDER

ENTERED OCTOBER 9, 2020

COMES NOW, the Defendant Thomas Schoenberger, (hereinafter "SCHOENBERGER"), pursuant to Florida Judicial Rule 1.540(b) requests the Court for a MOTION FOR REHEARING AND AMENDED MOTION TO VACATE ORDER ENTERED OCTOBER 9, 2020; on the grounds of new evidence of Plaintiff Gabe Hoffman (hereinafter HOFFMAN) for the same and additional reasons; Defendant SCHOENBERGER receiving additional intimidation and death threats from HOFFMAN, including but not limited to other misconduct of an adverse party suspected to be connected to HOFFMAN.

Defendant SCHOENBERGER affirms his request the Order be vacated pursuant to Florida Rule Civ. P. 1.540(b). Defendant's Motion to Vacate said Order was filed within

ten (10) days of the hearing of October 8, 2020 and subsequent Order October 9, 2020.

Defendant SCHOENBERGER hereby submits an AMENDED MOTION TO VACATE ORDER ENTERED OCTOBER 9, 2020 AND MOTION TO RE-SCHEDULE HEARING with the following new evidence, which developments further serve to strengthen the argument that the Order be vacated of October 9, 2020.

1. An order was entered on October 9, 2020 upon Defendant SCHOENBERGER's seeming failure to appear virtually, for the October 8, 2020 hearing on Plaintiff's Motion to Compel Response to Plaintiff's First Request for Production to Defendant and Response to Plaintiff's First Interrogatories to Defendant (Filing# 113517490, filed 9/17/2020).

2. At on or about 4:07 a.m. Mountain Time, on October 8, 2020, prior to aforementioned hearing of October 8, 2020, Defendant SCHOENBERGER received an email that contained a specific death threat and made reference to SCHOENBERGER'S performance name, 'St. Germain' and stated SCHOENBERGER would have a 'Last Supper' and then forced to 'dig my own grave.' Hereby attached as Exhibit 1.

3. Defendant also received a death threat from a blocked number that same morning, followed by communications on both his phone and computer malfunctioned twelve (12) minutes prior to the hearing. Defendant SCHOENBERGER was unable to obtain communications to virtually attend the hearing. Both cellphone and computer communications were malfunctioning for approximately an hour.

4. Plaintiff HOFFMAN, who has publicly accused SCHOENBERGER of being behind a movement called Q Anon, himself showed up virtually in court using the letter Q. Ironical, especially considering the phone call and email death threats which falsely claimed SCHOENBERGER was Q and needed to "dig my own grave" which intimidates, mocks, and shocks, not only this court, Defendant, but friends, family and close associates of SCHOENBERGER. See attached

Exhibit 2.

5. Dennis Klein, counsel for HOFFMAN has described before this court, that Q as a death cult. HOFFMAN has publicly and repeatedly excoriated Qanon, using the same vocabulary. With HOFFMAN appearing as Q in the October 8, 2020 hearing, within hours of documentable death threats against me, it is more than plausible to believe that SCHOENBERGER was targeted by phone email and hack. HOFFMAN is playing fast and dirty with the court. Why would HOFFMAN appear on the court zoom hearing as Q, unless he was making a mockery of these proceedings?

6. In the email death threat (Exhibit 1), the threat includes a promise that SCHOENBERGER would be a target of mainstream media by the 17th.

7. On October 16, 2020, SCHOENBERGER was the subject of two mainstream media propaganda hit piece articles, claiming that SCHOENBERGER is the mastermind of Q Anon. Defendant SCHOENBERGER patently claims these attacks false. These direct targets of SCHOENBERGER, have put the life of SCHOENBERGER at risk. Defendant is in fear of his life by these events, in addition to Plaintiff HOFFMAN claims that a memo had been sent out by an FBI field office in 2019 alledging Qanon as a domestic terror organization.

8. The confluence of the timing of the death threats, the obvious hacking of Defendant's communications, the major media propaganda hit pieces that published exactly as threatened, are new material evidence to this case.

9. Arturo Tafoyovsky (hereinafter TAFOYOVSKY) a known associate of Plaintiff HOFFMAN bragged about being behind the media attacks, see Exhibit 3. Why else would HOFFMAN appear in the court zoom hearing meeting if not to both mock the court, and continue his documented bullying of SCHOENBERGER? See Exhibit 2. TAFOYOVSKY is a self-professed hacker. It's a question, would TAFOYOVSKY have the technical ability to disable phones and computers?

10. Manuel Chavez, III (hereinafter CHAVEZ) another known associate of Plaintiff HOFFMAN is seen laughing on camera during court zoom hearing

proceedings October 8, 2020, see Exhibit 4.

11. On or about November 8, 2020, HOFFMAN video recruiting CHAVEZ see Exhibit 5 video as filename: Filename: 2020.11.08-HoffmanvSchoenberger-Hearing-Chavez .

12. CHAVEZ has in the past issued death threats to me, my ex-girlfriend and her family on or about November 2018. See Exhibit 6 video as filename: 2018.Spring-HoffmanvSchoenberger-Hearing-Chavez-threatens-Beth-Blackburn-Boegarts

13. CHAVEZ has in the past, on or about August 1, 2019, issued a bounty for my whereabouts. See Exhibit 7.

14. On or about May 14, 2019 HOFFMAN was unknown to SCHOENBERGER at the time HOFFMAN began attacking SCHOENBERGER on or about May 28, 2018. See Exhibit 8.

15. On or about December 2019, TAFOYOVSKY had a falling out with CHAVEZ (aka DEFANGO) and HOFFMAN. TAFOYOVSKY publicly released discord communications, providing irrefutable evidence that SCHOENBERGER was targeted by HOFFMAN (aka OPEN SECRET), CHAVEZ (aka DEFANGO) and TAFOYOVSKY (aka LESTAT). See Exhibit 9.

16. Additionally, that money was not only exchanged, but CHAVEZ even offered to pay for "trolls." CHAVEZ was in poverty prior to his communications with HOFFMAN. Hoffman possesses resources and a history of bullying. HOFFMAN has two (2) additional cases before this court for similar bullying tactics.

1: HOFFMAN, GABE V ALEXANDER, ALI 50-2019-CA-013281-XXXX-MB filed October 14, 2019; and

2: HOFFMAN, GABE V JACQUEZ, JULIO CESAREO 50-2019-CA-016488-XXXX-MB filed December 27, 2019.

17. In an article from Burners.Me, TAFOYOVSKY (aka LESTAT) communications with CHAVEZ (aka DEFANGO aka ILLUSIVEMAN) ILLUSIVEMAN being another sock name of HOFFMAN associate CHAVEZ.

Due to these strange and disturbing developments, I pray relief before the Judge, that this Court REHEAR the original hear set forth October 8, 2020 by VACATING the Order of October 9, 2020. I believe the above to be clear evidence of targeted attacks. It is a logical deduction to assume the attack on my communications was premeditated, as evidenced by the Exhibits attached, fitting a pattern.

Defendant SHOENBERGER having requested a re-hearing pursuant to Fla.R.Civ.P. 1.530, October 15, 2020. Said Motion was filed within timely manner. The reasons for requesting a rehearing is to appropriately defend myself in this case, as pro se.

WHEREFORE, I respectfully request that the Court grant this MOTION FOR REHEARING AND AMENDED MOTION TO VACATE ORDER ENTERED OCTOBER 9, 2020.












of them. As a result, interest in Q subsided and it was neglected for many decades.

This state of affairs changed in the 1960s after translations of a newly discovered and analogous sayings collection, the *Gospel of Thomas*, became available. James M. 16. In January 2006, Biss filed suit on behalf of the Lecher Family Business Trust (LBFT) against ULC, Shield and other named defendants.

17. The suit sought to assert claims against ULC that had been assigned to LBFT by Garcia, the original failed refuge company. Garcia assigned these claims to LBFT in January 2006.

18. The theory of the case was that Shield and ULC collected an excessive amount of money from Garcia, resulting in claims that Garcia assigned to LBFT.

19. Although he served as counsel for LTR in the 2004 suits and on appeal in the bankruptcy matter, in this case Biss alleged that LTR was "a dummy company, organized by ULC to perpetrate fraud, gain an unfair advantage, and commit injustice," and that LTR was ULC and Shield's "agent and stooge."

20. The defendants moved to dismiss the Biss complaint on the basis that


